In light of ongoing concerns regarding the COVID-19 pandemic, public attendance at Des Peres Board of Adjustment meetings has been temporarily limited in compliance with St. Louis County Executive Order #11 issued by the Department of Health. The City of Des Peres has made arrangements to livestream Board of Adjustment Meetings during this pandemic to allow the general public to observe meetings in real-time. The Board will consider the following items:

- 1) A request by Chesterfield Fence and Deck, on behalf of Chris Little, property owner, for one variance at [527 Ballas Trails Drive](#), to construct an uncovered deck that would encroach 18' into the rear yard setback, establishing a 22' rear yard setback. Section 404.020 B.4 requires a 40' rear yard setback in the D-Residential Zoning District.
- 2) A request by Laura and Ken Wilhelm, property owners at [1644 Dunmorr Drive](#), to construct a 750sqft three car garage attached via breezeway that would encroach 8'6" in to the side yard setback, establishing an 11'6" side yard setback. Section 404.010 B.3 requires a 20' side yard setback in the AA-Residential Zoning District.
