Site Plan: Two (2) scale copies of a site plan showing the location of all proposed work and location of existing buildings (not required for interior residential remodels) and distances to all property lines; 2. Two sets of construction documents/plans; 3. Processing/plan review fee of \$100 due at time of submittal 4. Permit Fee (\$6 per \$1,000) collected when permit picked up 5. Refundable deposit: a check (collected when permit picked up), for a refundable deposit is required with all permit types. The department will not review incomplete applications or plans. Applicants must obtain mechanical, electrical and plumbing permits from the St. Louis County Department of Public Works prior to commencing construction. 7. I understand that deed restrictions and subdivision indentures may exist on said property, which are not reviewed or enforced by the City of Des Peres. The City recommends the property owner review the deed, subdivision plat, subdivision indentures, and other property title information before undertaking any construction. 8. Inspections must be scheduled at least 24 hours in advance. Must email the Building/Public Works Department (Permits@desperesmo.org) to schedule inspection.
